## FROM THE CHAIRMAN



Society for Service to Voluntary Agencies (North) Punjab (SOSVA) has been designated as Mother NGO by the Punjab Government. As a mother NGO we have interface mainly with the Health and Women & Child Development Departments of the Punjab Government.

SOSVA acts as a link between the Government and field NGOs. It acquaints them with various programmes for which grant-in-aid is admissible and the eligibility conditions for availing the same. It identifies credible NGOs engaged in social work and extends them a helping hand to source financial assistance to enlarge activities and augment their resources.

SOSVA has been associated with the Health Department since 15th October 1999 for implementing Reproductive and Child Health Programme (RCH) in underserved rural areas through field NGOs. Now that the health infrastructure has expanded both in urban and rural areas and ASHAs and ANMs cover the entire state, our focus has shifted to urban slums for creating awareness about various programmes for the benefit of pregnant and lactating women, adolescent girls, children and citizens at large. Our endeavour is to bring health indicators in these areas at par with the State average. The programme also includes Yoga training and organising Ayurveda Camps and hand holding in availing various beneficial schemes. The programme is implemented in close coordination with the local level functionaries of Health and Ayurveda Departments and anganwari workers of Women and Child Development Department. During the Year 2021-22, 12 RCH projects were implemented.

The Women & Child Development Department provides grant-in-aid for implementing various programmes for skill development of women from poorer sections. Training is imparted for six months in Computer Applications, Cutting & Tailoring, and Hair & Skin Care. Another training programme for Home Care for Elderly and Chronically Sick persons has also been introduced. Besides, projects for child nutrition and awareness against drug addiction are also implemented. We were able to implement 95 projects for imparting training to poor women in various skills and 4125 women were trained. Feedback from them shows that some of them are doing pretty well while others are earning modest amounts. But most importantly after training they gain confidence and acquire a feeling of self-respect.

As Field NGO, SOSVA implemented HIV/AIDS projects at Phagwara. Besides, remedial coaching was provided to weak students of 3rd standard in about 66 Government schools in Mohali. This project, during the year, could only be partially implemented for about two months as schools remained closed due to COVID-19 and the balance unused amount was refunded to the Education Department.

We are grateful to the Government of Punjab, particularly the Departments of Health & Family Welfare; Social Security, Women and Child Development; Education; Planning and Finance, and Punjab State AIDS Control Society for the confidence reposed in us as Mother/ Field NGO for implementing their programmes.

My esteemed colleagues Shri BB Mahajan, Brig Keshav Chandra, Shri SK Verma, Dr GL Goyal, Dr HS Sandha, Dr BC Gupta and Dr DK Verma (Member Directors) and Dr Mrs Reena Singh (Board Member) have been monitoring and mentoring projects and making valuable contribution for effective implementation of various programmes.

Our Programme Managers and support staff are highly motivated and they have been working with dedication, devotion and commitment.

## **SOCIETY FOR SERVICE TO VOLUNTARY AGENCIES (N) PUNJAB AS MOTHER NGO**

### **Background**

Society for Service to Voluntary Agencies (SOSVA) was founded in Pune (Maharashtra) in 1984 by a team of eminent doctors under the leadership of Dr Bano Coyaji. Over the next few years it extended its activities to Karnataka, Delhi, Haryana, Punjab and Chandigarh. The Northern Chapter, with Headquarters at Delhi and catering to the Northern states of Punjab & Haryana, National Capital Territory of Delhi and UT of Chandigarh, was registered as a separate Society in 1999. Later, in 2002, in order to conform to Revised RCH Project Guidelines issued by the Union Ministry of Health and Family Welfare, the state units were registered as independent entities. SOSVA (North) Punjab, registered in 2002, looks after the activities in the State of Punjab.

### **Concept of Mother NGO**

Private charity and donations have traditionally been the mainstay of voluntary movement in our country and many organizations are doing excellent work at various levels. However, field NGOs at the grass-root level need support in terms of information on projects for which funding is available, guidelines for project preparation and their submission to the funding agencies. Similarly, the donor agencies and various Govt. Departments who wish to involve NGOs in implementing their programmes are keen to know about the credibility of the field NGOs before committing grants. They also want to know about the specific areas of interest of the field NGOs. This is where the need was felt for a special kind of NGO to provide requisite service to the donors as well as recipients of grants. Such an NGO with requisite competence is designated as a Mother NGO.

### **SOSVA (North) Punjab as Mother NGO**

SOSVA (North) Punjab has been recognized as Mother NGO by Departments of Health & Family Welfare and Social Security, Women and Child Development, Government of Punjab. It has helped in bringing field NGOs and the State Government into an active and mutually beneficial relationship. While eliminating procedural delays and uncertainties for the voluntary agencies, SOSVA provides the Government assured access to reliable field NGOs and an effective project monitoring mechanism of their functioning.

### **Role of SOSVA as Mother NGO**

As a Mother NGO SOSVA gets projects implemented through field NGOs. The requirement of funds for the programme during a year is assessed by SOSVA and conveyed to the Department of Health & Family Welfare for RCH projects and Department of Social Security, Women & Child Development, for skill training of poor women and nutrition of children and awareness against drug addiction projects which, in turn, convey these to the Department of Planning. The sanction of funds for various programmes in favour of SOSVA is conveyed by respective departments after allocations are approved by the Apex Committee on NGOs chaired by the Chief Secretary.

**Selection of NGOs and Appraisal of Projects.** SOSVA issues an advertisement every year inviting applications from NGOs for grant in aid. Efforts are also made with the help of Deputy Commissioners and District Level Officers of Health & Social Security Departments to identify suitable NGOs capable of implementing the programme effectively and with dedication. The



applicants are required to provide information about the activities undertaken and the projects implemented by them. The applications are scrutinized to check their eligibility and track record (in case they have implemented any projects under SOSVA in the past). Thereafter their capability for implementation of the projects is appraised by field visit by the Chairman or Member Directors along with the Programme Managers. The proposals, with detailed Appraisal memoranda and our recommendations, are placed before the Sanctioning Committee which includes representatives of the State Government. Sanctions for the projects to be implemented during the year, with detailed budget and guidelines are thereafter issued by SOSVA to field NGOs.

**Guidelines for NGOs.** NGOs are issued detailed guidelines for each type of project which include syllabus, qualifications of the teacher to be engaged, the infrastructure to be provided by the NGO, and maintenance of records and accounts.

**Release of Grant.** The grant is released to the NGOs in instalments for each batch. First instalment is released on the receipt of necessary documents and, in case of NGOs which had implemented a project during the previous year, on receipt of utilization certificate and progress report for the projects implemented during the previous year. Subsequent instalments are released on receipt of quarterly progress report, UC for the 1st instalment and after reviewing performance through visits by Chairman, Member Directors and Programme Managers.

**Utilization Certificates.** Utilization Certificates obtained from the NGOs, for the funds released for the whole year, are scrutinized to ensure that expenditure has been incurred in accordance with provisions in the sanctioned budget and a consolidated UC for the total grant released is submitted to the State Government.

**Coordination with State Agencies.** SOSVA, as Mother NGO, takes up with concerned department issues that may arise during implementation of the projects by field NGOs. For instance it takes up with the Health Department the problems relating to erratic supply of IFA tablets, calcium tablets (for distribution to pregnant women, lactating mothers and children) or non-availability of Vit. A doses (to children below 6 years) inadequate number of outreach camps etc. in areas where RCH projects are implemented. With the Department of Social Security Women and Child Development, it takes up problems, if any, regarding inadequate number of Anganwadis in the project area, non availability of nutrition (for pregnant women, lactating mothers and children) and delay in disbursement of benefits available for pregnant women under Pradhan Mantri Matritva Vandna Yojna. It co-ordinates with the Department of Education for issue of instructions to District Education Officers for extending cooperation to NGOs for organising various events regarding awareness against drug addiction in Senior Secondary Schools, and Colleges in the project area.

## **Staff**

Monitoring and follow up of implementation of projects is being done by a team of four dedicated Programme Managers namely, Sh TS Gill, Sh Vijay Kumar Sharma, Ms Saroj Bala and Sh Parmod Sobti. Sh SPSahni, PA, provides secretarial support. Besides, a driver and an office helper have been engaged.

Two Project Managers with complementary staff of two Monitoring & Evaluation Assistant-cum-Accountant, Outreach Workers and two GNMs and Counsellor have been engaged for implementing Targetted Intervention Project for HIV/AIDS among FSWs and MSMs and for IDUs in Phagwara, funded by Punjab State AIDS Control Society.

## REPRODUCTIVE AND CHILD HEALTH PROGRAMME

### General

The programme is implemented mainly in slums and areas inhabited by the poor where major health indices are below the State average.

### Objective

The main objective of the Reproductive and Child Health Programme is to supplement the efforts of the State Government to improve health status of the poorer section and in particular :

- a. To improve the health status of pregnant women and reduce maternal mortality.
- b. To improve the health status of children up to 6 years age and reduce infant and child mortality.
- c. To improve the health status of adolescent girls and sensitizing them about menstrual hygiene.
- d. To improve health of general population by creating awareness regarding nutrition, personal hygiene & sanitation, and harmful effects of intoxicants.
- e. To create awareness regarding major non-communicable diseases and promoting annual medical check up of persons above 30 years of age for timely detection of any major disease.
- f. To promote use of Ayurveda and Yogic exercises for improvement in general health status.
- g. To improve the sex ratio by discouraging female foeticide and removing bias against female child in regard to nutrition, medical care and education.

For achieving the above objectives, NGOs work in close coordination with field staff of the concerned departments viz ANMs, ASHA workers and Anganwadi workers.

### Role of NGOs

NGOs have an important role in:

- a. Creating awareness for behavioural change on various issues regarding health of pregnant women, adolescent girls, young children, lactating mothers and others from poorer sections of society through group discussions & visits to households.
- b. Persuading and, when necessary, helping targeted population to take benefit of Government schemes for:
  - i. Control of anaemia among pre-school children, school going children, out of school adolescent girls and lactating mothers.
  - ii. Use of calcium by pregnant women and lactating mothers.

- iii. Supplementary nutrition for pre-school children, pregnant women and lactating mothers.
- iv. Cash benefits for delivery to women from SCs and BPL families and to pregnant women with no living child.
- c. Persuading pregnant women to undergo check up by the doctor during pregnancy and persuading persons above 30 years age to avail of free Annual Medical Check up.
- d. Persuading pregnant women and other intended beneficiaries to attend outreach camps organized by Health Department in their area.
- e. Supplementing efforts of Health Department by undertaking supply of sanitary napkins at subsidized rates to adolescent girls to promote their use.
- f. Creating awareness against female foeticide and discrimination against female child in medical care, education and nutrition through interactive sessions, debates, declamation contests etc in schools and colleges.
- g. Organizing camps for promoting use of Ayurvedic treatment and home based remedies with the help of Ayurvedic doctors from the district and organizing classes for yogic exercises for improvement in general health status.

### **IEC Material & Other Publications**

IEC material in the form of booklets, posters, pamphlets and flexes etc. was prepared centrally by SOSVA in regard to various aspects of the programme. Printed copies were supplied to field NGOs for use by field workers and distribution among beneficiaries. In addition, revised edition of the booklet on Health of Pregnant Women, Children & Adolescent Girls, Nutrition, Family Planning, and HIV/AIDS etc. (containing information in Punjabi in questions and answers form was published and circulated among field health workers.

### **Projects to be Implemented out Of Budget Grant for 2020-21**

The Apex Committee on NGOs allocated an amount of Rs. 63 Lacs out of the budget grant for the Year 2020-21 for Reproductive & Child Health (RCH) programme under Plan Scheme PM 6 "Assistance to NGOs". NGOs were sanctioned RCH projects as approved by the Sanctioning Committee out of which 12 are being implemented from 1st July 2021 to 30th June 2022

## **WOMEN & CHILD DEVELOPMENT & DRUG DE-ADDICTION PROGRAMME**

### **Objectives**

The main objectives of the programme are:

- a. To empower poor women by imparting useful skills, which would help them to contribute to the family's income.
- b. To assist in physical and mental development of pre-school children from poor families through supply of proper nutrition, IFA tablets, toys and books, and nursery education.
- c. To create awareness against drug addiction among students of Secondary and Senior Secondary classes.

### **Programme for Imparting Skills to Women**

The NGOs are advised to ensure that at least 80% of the trainees are from poorer families such as those below poverty line, SCs, Blue Card holders (under subsidized atta dal scheme of the State Government), widows, divorced women and those from low income occupations like landless agricultural workers, construction labour, brick kiln labour, unskilled factory workers, domestic servants, hawkers, rickshaw pullers etc.

The target set for the NGOs is that at least 70% of the trainees should be able to contribute to their family income through direct employment, piece-rate work or self employment within 6 months of completion of training.

Projects are sanctioned for training of poor women in Cutting & Tailoring, Hair & Skin Care, Computer Operations, and Home Care of Elderly and Chronically Sick Persons.

Training is given in two batches for six months each. One batch normally comprises 25 women. Training is imparted by qualified instructors for four hours a day, six days a week.

To enable trainees to secure gainful employment/ self employment, the syllabi are based on requirement of the market. On completion of the course, trainees are got examined by ITI trained teachers or those trained from other similar organizations.

The women having received training in Cutting & Tailoring are provided sewing machines costing about Rs.2200/- and those having been trained in Hair & Skin Beauty Care are given kits worth Rs.1,500/- to help them in gainfully utilizing their training without loss of time.

While identifying specific skills for which training is to be imparted in a particular area, due consideration is given to the following:

- a. Whether identified trainees can acquire specific skill.
- b. Whether similar training has already been imparted in the area or its vicinity in the recent past.
- c. Whether it will be possible for the trainees to gainfully utilize the training for securing employment, including piece rate work and self employment

## **Programme for Creating Awareness against Drug Addiction**

Objective of these projects is to create awareness among students of secondary & senior secondary schools & colleges against dangers of drug addiction and persuade those already addicted to take treatment from drug addiction centres.

Ten projects were sanctioned but could not be implemented as all educational institutions were closed due to COVID-19 Pandemic.

## **Programme for Child Nutrition**

Children in the age group of 3-6 years living in slum areas which are not covered by the Anganwadi Scheme are provided nutrition, IFA tablets, books and toys to ensure their proper development. These children are looked after for 4 hours a day and provided free wholesome food in hygienic condition and given elementary lessons in personal hygiene. Children above 3 yrs are also imparted free nursery education by Nursery Trained Teachers. Three projects were sanctioned but could not be implemented due to Covid.

## **Projects Implemented out of Budget Grant for 2020-21**

Seventy three NGOs were sanctioned 105 projects out of Budget Grant for the year 2020-21. Subsequently, eighteen more projects were sanctioned at the meeting held on 22nd June 2021. COVID 19 pandemic affected implementation in the following manner:

- a. Of the 123 skill development projects for training of poor women in Cutting & Tailoring, Hair & Skin Care, Computer Operations, and for Home Care of Elderly and Chronically Sick Persons only 95 could be implemented. Projects for child nutrition and awareness against drug addiction could not be implemented.
- b. Projects scheduled to be implemented from 15 March 2021 to 9 October 2021 and from 15 October 2021 to 14 March 2022 were delayed and could be conducted only for one batch (01 October 2020 to 15 March 2021).

## **Projects to be Implemented out of Budget Grant for 2021-22**

The Apex Committee on NGOs at the meeting held on 6th June 2021 allocated an amount of Rs. 125 lakhs out of the budget grant for the Year 2021-22 for programmes of Department of Social Security, Women and Child Development under Plan Scheme PM 6 "Assistance to NGOs" through SOSVA. The Sanctioning Committee met on 9th March 2022 and approved Eighty eight projects mainly for training of women in Cutting & Tailoring, Hair & Skin Care, Computer Operations. The grant was, however, not received and projects could not be implemented.

## **Projects to be implemented out of Budget Grant for 2022-23**

State Government was requested to revalidate the sanction issued out of budget grant for 2021-22 which had lapsed. The Government has issued sanction for Rs. 87.29 Lacs out of vote on a/c for budget 2022-23. The Projects will be implemented from 1.7.2022 to 31.12.2022.

## **PROGRAMMES IMPLEMENTED/TO BE IMPLEMENTED AS FIELD NGO**

### **Free Coaching of Weak Students at Primary Level out of Budget Grant for 2020-21**

Under this programme, SOSVA as a field NGO with grant from School Education Department under Plan Scheme PM 6 imparts free coaching in 53 centres in Distt. Mohali. In each centre 12 to 16 weak students in class III (average 15 students per centre) are enrolled and given coaching for 2 hours daily after school hours in Punjabi, English, Arithmetic and Environmental Studies.

The objective is to improve their learning ability so that by end of the coaching they may be able to study in the class with rest of the students. Qualified teachers are appointed in the centres and are paid an honorarium of Rs 2000 per month. Students are provided exercise books. At the end of the project, tests are given to all students to judge the extent of improvement in their learning ability.

### **Status regarding implementation of Project out of the grant 2020-21**

An amount of Rs 14.10 Lakhs was sanctioned as Grant-in-Aid in favour of SOSVA (N) Punjab, out of budget grant for 2021-2022 which was received on 25th March 2021 for running the project of Free Coaching for weak students at primary level in Distt. Mohali, but due to Lockdown owing to COVID, all the schools were closed and the project could be implemented only for 1 month and 25 days in Unit I and 2 months and 11 days in Unit II. A sum of Rs 5,00,308/- (Five lakh three hundred and eight only) has been spent during the period 1st September 2021 to 28th February 2022. An Unspent amount Rs. 9,09,692 (Nine Lakh nine thousand six hundred ninety two) has been refunded to the Department of School Education, Punjab.

### **The position regarding implementation of the Project in District Mohali is indicated below :**

The coaching classes were to be started from 1st September 2021 to 15th February 2022 for a period of 5½ months in 70 centres (2 units of 35 each) in Govt. and Govt.-Aided Schools with target of enrolment of 12 to 16 students in each centre with average of 15 students. The total number of students to be enrolled was thus 70 x 15 = 1050.

However, since the schools in Distt. Mohali were closed by Administration due to "COVID" restrictions, the coaching could start in 32 centres from 8th November 2021, in 34 centres from 25th October 2021. 990 weak students were enrolled.

It had been planned to continue the coaching till 15th February 2022 however due to COVID 19 restrictions again, the schools were ordered to be closed on 04th January 2022. In this way the coaching was done for one month 25 days for unit-I and two months 11 days for unit-II.

No grant for the Project was requested out of budget 2021-22 as required funds were available out of budget 2020-21.

### **HIV/AIDS Project**

**Budget Grant 2021-22.** Punjab State AIDS Control Society (PSAC) sanctioned Grant in Aid for two projects at Phagwara during 2021-22:

- a. Rs.19,58,00/- for Targeted Intervention Project for Female Sex Workers (FSW) and Male Sex Workers (MSM)
- b. Rs.20,68,601/- for Targeted Intervention Project for IDUs (Injecting Drug Users).

Service was provided to 587 FSWs against a target of 400. Against the target of 300 MSMs, 316 were taken on roll and provided necessary services. The target for the year for IDUs was 600 against which 724 were registered.

The meeting of the Apex Committee on NGOs was held 18th November 2019 in which allocations were made as under for various programme to be implemented during 2020-21.

### As Mother NGO

We have sent proposals for projects to be implemented through field NGOs as Mother NGO for:

- a. Re-productive and Child Health (RCH) and
- b. Women & Child Development & Drug De- addiction

Projects will be implemented on receipt of sanction from the Planning Department and with the approval of Sanctioning Committee.

### As Field NGO

**Education.** Proposal for Free Coaching for Weak Students at Primary Level in Distt. Mohali during 2021-22 at a cost of Rs 14.10 lakhs has been approved by Sanctioning Committee on Voluntary Agencies (SCOVA) of School Education Department

The project will be implemented for 7½ months w.e.f. 1st July 2021

**HIV/AIDS Projects at Phagwara.** Continuation for Targeted Intervention Projects for Female Sex Workers (FSW) and Male Sex Workers (MSM) and Project for IDUs (Injecting Drug Users) of Punjab State AIDS Control Society have been sanctioned from 1st April 2021 to 31st March 2022 (at Rs 19,58,000 and Rs 20,68,601 respectively) and are under implementation.



## **ACCOUNTS**

### **Audit of Accounts**

The accounts of the Society have been audited by M/s. S. Tandon & Associates, Chartered Accountants, Competent House, C-157 Phase - 7 Industrial Area, Mohali.

Utilization certificates for RCH projects and Projects of Women and Child Development and Drug De-addiction have also been submitted to the concerned departments.

Utilization certificates in respect of HIV/AIDS projects have been submitted to Punjab Government and Punjab State AIDS Control Society and UC for programme of Education Department has been sent to that Department.

### **Grant from His Excellency Governor of Punjab**

His Excellency Governor of Punjab has sanctioned a grant of Rs. Five Lakhs to the Society for purchase of computers, printers etc. to modernize the office of Society. We are grateful to His Excellency for the grant which will go a long way in improving the efficiency of the Society.

We are grateful to State Bank of India for giving a grant of Rs.. 15.00 Lakhs out of CSR to the Society.

### **Donations**

Donations to the society are eligible for tax deduction under section 80 G of the Income Tax Act 1961.
